

SecOps Europe 2018 International Exercise and Conference on Security Operations (referred as 'Event')
Budapest, 24-25 January, 2018

VISITOR POLICY

ADMITTANCE TO THE EVENT

- 1./ Visitors are admitted to the Event at the times and according to the conditions specified by this policy. By entering to the Event, you acknowledge that compliance to this policy can be checked and enforced by the organizers.
- 2./ Entry is only permitted with valid tickets which will be exchanged to badges at the first entry.
- 3./ Visitors are required to wear their badges for the duration of the Event. Event organisers will inspect badges at the entrance. Visitors with invalid badges aren't permitted to enter the Event venue. Badges are non-transferable. As a general rule, lost or damaged badges are invalid. The Organizers will not replace damaged or lost wristbands.
- 4./ In order to ensure the safety of the Event, the Organizers reserve the right to restrict the types of items and devices which may be brought inside the venue. Accordingly, bringing the following in particular to the Event is prohibited: pyrotechnic devices, glass objects, objects or tools containing explosive, poisonous or flammable materials, firearms, knives with a blade longer than 8 cm, butterfly knives, switchblades, gas sprays, expandable batons, metal chains over 50 cm in length, throwing stars, slingshots and other items posing a special threat to public safety as defined in relevant laws and regulations (currently: Government Decree No. 175/2003 of 28 October 2003). Visitors in possession of any prohibited item may not enter the Event venue.
- 5./ Animals are not permitted into the venue.

RULES OF CONDUCT

1./ In the Event area, the employees of ProDay Rendezvényszervező Kft. and Black Cell Kft. (Organizers) and their associates (Blueteam Kft.) will ensure enforcement of the rules of conduct and safety. Visitors expressly undertake, by virtue of their participation in the given Event, that they will fully cooperate with these associates within the bounds of the law and will follow their instructions. Both the Organizers and the associates are wearing distinctive marks (badges with a yellow stripe), therefore they can be easily identified.

2./ In the Event area, the Visitors should comply to all the basic behavioral and lawful norms and policies. Visitors have to also comply with this policy, and to behave in such a way so as not to disturb, hinder, limit or prevent other Visitors from enjoying the Event.

3./ Visitors acknowledge that The Organizers, its Contracted Partners as authorised by Black Cell Kft., Contributors, and members of the press (*in accordance with the stipulations of special agreements concluded with them*), as well as other Visitors and other third parties, may produce sound and image recordings of the Event.

Accordingly, all Visitors to the Event, by virtue of their participation at the Event, give express permission to the recording and publication of their image, likeness and actions. Visitors, however, may only be named in such recordings with their express permission. Visitors considered public figures may be named without their permission.

Those making recordings according to the above rules shall gain transferrable and exclusive usage rights that are unrestricted in time, geographical location and form of usage. Black Cell Kft, as well as individuals authorised by Black Cell Kft., are entitled to utilise, use (*especially for the promotion of the Event*), duplicate, publish, transpose, make public, transmit to the public and distribute such recordings of the Visitor without providing any compensation to the Visitor.

Visitors expressly acknowledge that Black Cell Kft may record the Events, presentations and programmes, may copy the recordings and distribute them on image-bearing media, may broadcast them or otherwise make them public and may do so repeatedly, including making the Events, concerts and programmes available to the public by wired or by any other means (for example, through YouTube), such that members of the public can individually select the place and time of access.

Visitors are not entitled to make any claim or demand against Black Cell Kft. concerning recordings as set out above. Visitors are entitled to make sound and image recordings at the Events, but may only make sound and image recordings with non-professional equipment (eg. mobile phones, tablet PCs, cameras without a tripod).

Visitors may not sell, use for consideration or use for commercial purposes without consideration image and voice recordings that they have made, name Visitors featuring in such recordings without

their consent or violate the personal rights of such Visitors. Black Cell Kft is expressly not liable in the event of other Visitors violating the above rules.

4./ No business, commercial or advertising activity may be conducted at the Event without advance written authorisation from Black Cell Kft.

5./ On-premises of the event, advertising, client and workforce recruiting, business proposing/bidding is strictly prohibited without advance written authorisation from the Organizers. In absence of this agreement, the Organizers and their Associates can call for the suspension of the action against the Visitor Policy. If this action is still conducted despite the warning, then the the ones conducted the action mentioned above are required to leave by the the Organizers. If the conductors refuse to leave, then the Associates are permitted to take the necessary steps.

To decide if an action is against the Visitor Policy is in the sole discretion of the Organizers.

6./ Visitors are required to refrain from all actions, statements or behaviour which endangers the life, health or physical well-being of others or which may violate others' personal rights. In case of non-compliance with the above the Organizers and/or their Associates have the right to expel visitors from the event. Along with this expelling, the Visitor is losing the right to any form of compensation regarding this event.

7./ In the Event area, the Organizers' suitably qualified and authorised employees or associates will ensure enforcement of the rules of conduct and safety. Visitors expressly undertake, by virtue of their participation in the given Event, that they will fully cooperate with these associates within the bounds of the law and will follow their instructions in the event of an emergency. MISCELLANEOUS PROVISIONS

1./ The Organizers may be held responsible exclusively for intentional breaches of contract caused by them, and expressly excludes any liability beyond the statutory rights of the Visitor with regard to any other damage event.

2./ Visitors wishing to provide feedback or ideas, or to file complaints in connection with hospitality vendor services, organisers or any other issues may address them to the staff or file them electronically, items lost and found may be handed to the Organizers, and visitors may inquire about lost items also there.

Not reading the Visitor Policy is not a release from complying it. Please read the rules carefully.
